### **Policy:**

SCAN, Inc. will use your information to respond to you, regarding the reason you contacted us. Unless you ask us not to, we may contact you via email in the future to tell you about new services or changes to this privacy policy.

As part of fund raising, donor information is used by SCAN, Inc. to thank donors, request contributions and inform donors of the results obtained through the use of their gift. Donor names are shared in annual reports, newsletters, event marketing materials, and on SCAN, Inc.'s website. We do not share details about the specific amounts. Donors may request that their names not be shared publicly.

SCAN, Inc. uses its best efforts to respect the privacy of its online visitors. At our site, we do not collect personally identifiable information from individuals unless they provide it to us voluntarily and knowingly. This means we do not require you to register or provide information to us in order to view our site. SCAN, Inc. only gathers personally identifiable data, such as names, addresses, zip/postal codes, e-mail addresses, etc., when voluntarily submitted by a visitor. For example, personally identifiable information may be collected in order to respond volunteer services at SCAN, Inc. or to make a donation online. This information is used solely by SCAN, Inc. or other entities who are involved in the operation of this site for internal purposes. SCAN, Inc. lists are never sold to third parties.

### **Log Data:**

Whenever you visit our site, we collect information that your browser sends to us that is called Log Data. This Log Data may include information such as your computer's Internet Protocol address, browser version, pages of our site that you visit, the time and date of your visit, the time spent on those pages, and other statistics.

### **Cookies:**

Cookies are files with small amount of data that is commonly used as an anonymous unique identifier. These are sent to your browser from the website that you visit and are stored on your computer's hard drive. The cookies in use on SCAN, Inc.'s website are for Google Analytics.

Google Analytics uses these "cookies" to collect information and to improve our services anonymously. It reports website trends without identifying individual visitors.

**Children's Privacy (COPPA):**

SCAN, Inc. does not knowingly collect personal identifiable information from children under the age of 13. In the case we discover that a child under 13 has provided us with personal information, we immediately delete this from our servers. If you are a parent or guardian and you are aware that your child has provided us with personal information, please contact us so that we will be able to do necessary actions.
